1. Invocation and Pledge of Allegiance to the U.S. and Texas Flags.

The meeting was called to order by Chairman Cyndi Mitchell at 7 PM. The invocation and pledge to the U.S. and Texas Flag was led by Lance Whitworth.

2. Consider Election of Officers

A motion was made by Terry Bennett and seconded by Lindsay Buhler to appoint Cyndi Mitchell as Chairman. Motion passed unanimously.

3. Consider approval of the minutes of the November 9, 2017 Parks and Recreation Board meeting.

A motion was made by Terry Bennett and seconded by Lindsay Buhler to approve the minutes as written. Motion passed unanimously.

4. Discuss and consider the Arbor Day/Great American Cleanup Event.

Ms. Wiseman gave a brief update on the event. It will be held on April 7 and emails will be sent out to groups at the end of the month requesting volunteers. This will be the City's 10th Year as Tree City USA. We hope that everyone from the board will be able to join us and help with the event.

5. Discuss and receive an update on the Community Center.

Mr. Whitworth reported that Ron Hobbs met with staff last week. He brought preliminary drawings of the concept and design using input from the citizens, board, and City Council. He is on the agenda for the 2nd meeting in February and he will bring some 3D concepts and drawings. We will bring regular updates to the board as things progress.

6. Discuss and receive an update on the MDD.

Mr. Whitworth reported that at the February 24 City Council retreat they will decide on the MDD Board. Once the board is chosen, staff will have a list of potential projects that will be proposed to the MDD board for consideration.
