Agenda items:

1. Approval of March 22, 2018 Minutes – Kirk Wood Motion to approve, Ted Kinzer 2nd. Motion carried.
2. Code of Ordinances Presentation – Chief Sylvester gave a brief recap of sections covered in previous ASB Meetings then presented Sec. 2-16 – Animal Bites and Rabies and Sec. 2-25 – Molesting or Releasing Animals. The Chief advised the Committee that this would conclude his presentations of the Code of Ordinances pertaining to Animal Control.
3. Quarterly Animal Shelter Report – Supervisor T. O'Neal presented the report to the Board and advised that the new format, while providing additional requested information, was still a work in progress with regard to 100% line item accuracy.
4. Shelter Activities update - T. O'Neal advised the Board that the Animal Shelter received a 100% passing grade at the August 30, 2018 DSHS Health Inspection. Also covered was the recent Animal Allies Shot Clinic October 6, 2018. Reported 130 vaccinated animals and 70 City registrations completed. The Shelter Shuttle program kicked off October 1, 2018.
5. Chief Sylvester and Terri O'Neal fielded questions from the Board on off-site adoption events, advertising and social media of adoptable animals, and shelter capacity numbers.
6. Jim Mathis requested future agenda items from the Board. Next Shelter Board meeting set for January 2019. The Board requested 2019 Shelter Board meeting dates be posted in advance.
